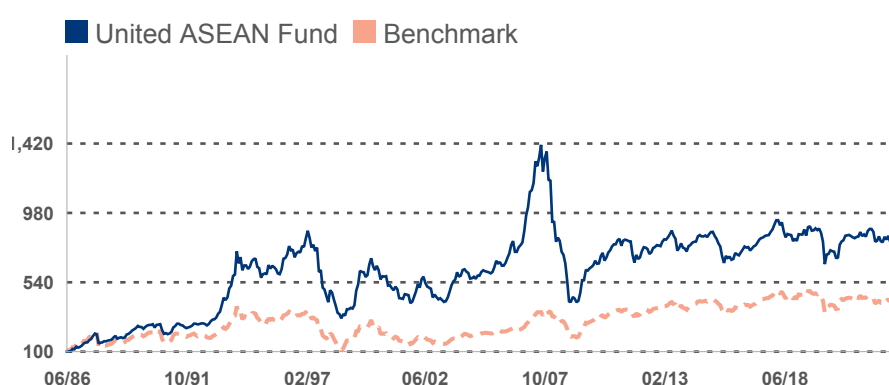


United ASEAN Fund

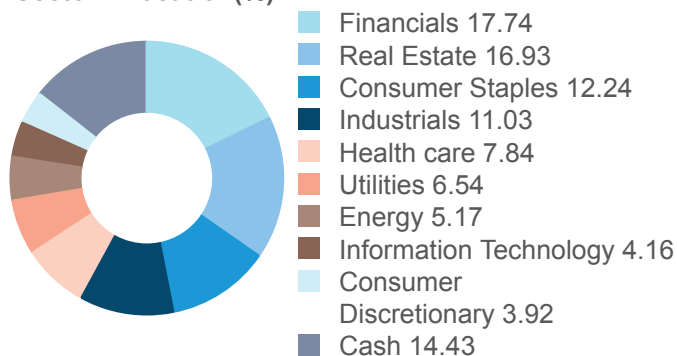

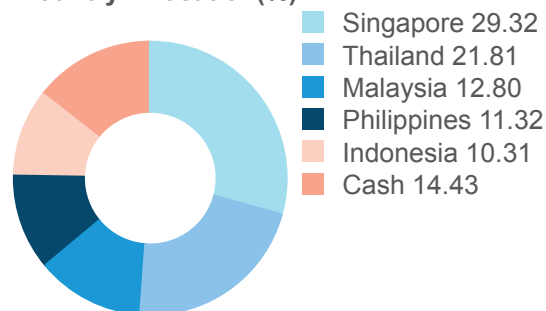
