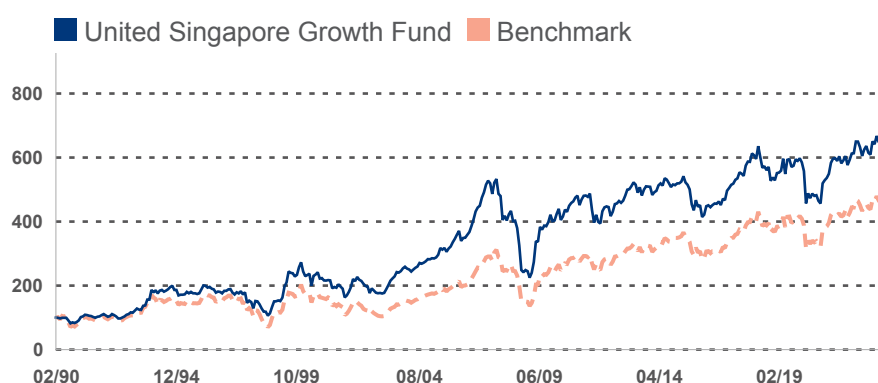


United Singapore Growth Fund

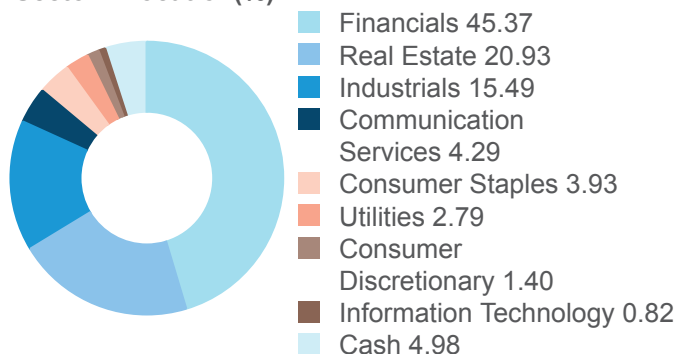

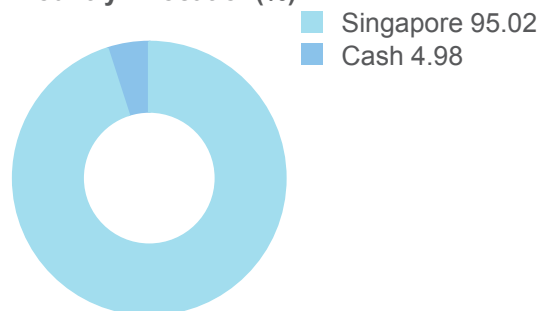
