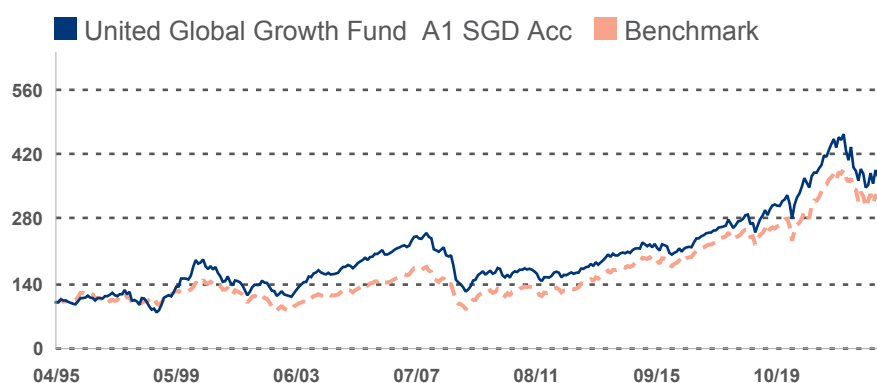


United Global Growth Fund

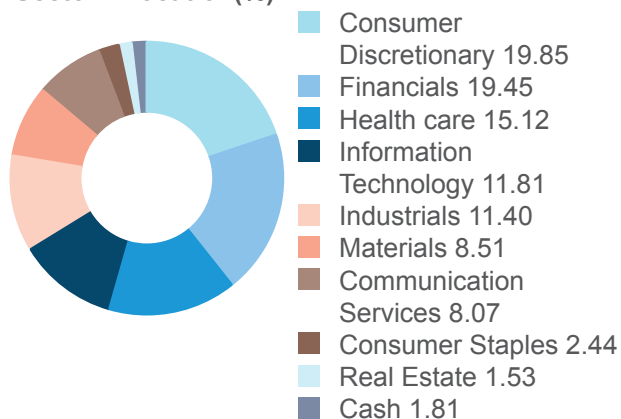

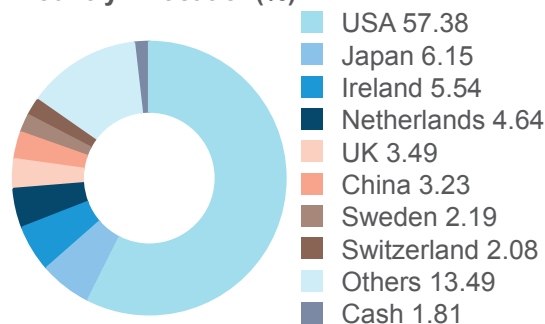
