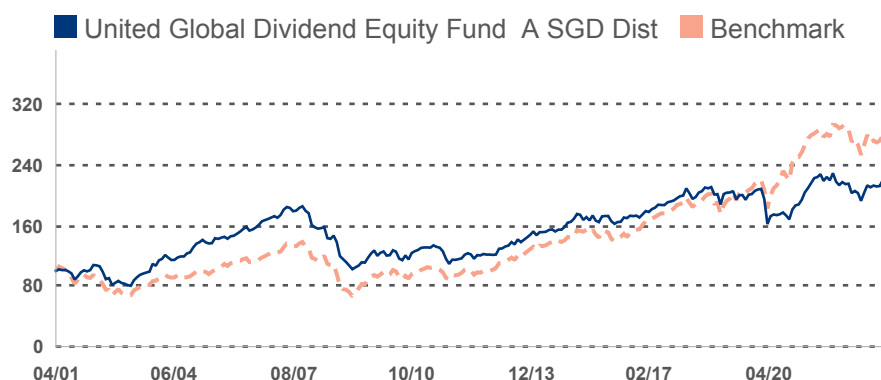


United Global Dividend Equity Fund

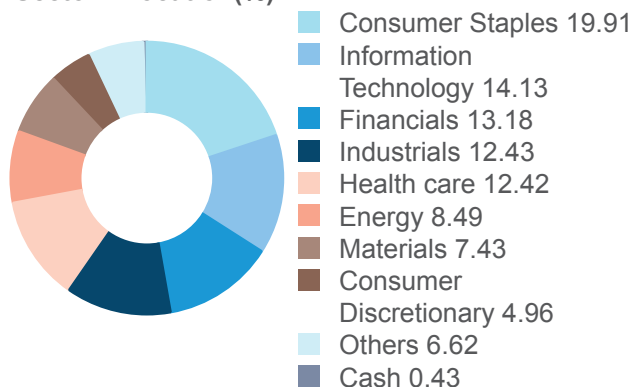

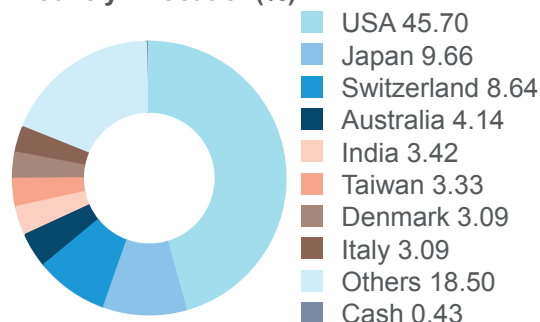
