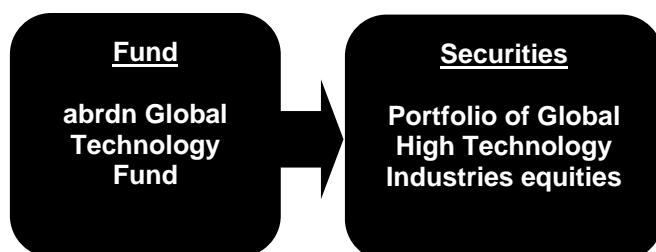

- You are investing in a Singapore-authorized unit trust, which aims to generate capital growth over the medium to long term by investing in global technology equities (company shares).

### INVESTMENT STRATEGY

- The Fund aims to outperform the MSCI AC World Information Technology before charges. The benchmark is also used as a reference point for portfolio construction and as a basis for setting risk constraints.
- The Fund is actively managed.
- The Fund invests in technology equities and equity related securities of companies or institutions involved in high technology industries anywhere in the world.
- The management team use their discretion (active management) to maintain a diverse asset mix at country, sector and stock level. Their primary focus is on stock selection using research techniques to select individual

<p><b>WHAT ARE THE KEY RISKS OF THIS INVESTMENT?</b></p> <p>The value of the Fund may rise or fall. You may lose some or all of your investment depending on the performance of the underlying securities. Factors that may affect the performance of these securities include, without limitation, market risks, fluctuations in interest rates and foreign exchange rates, political instability, exchange controls, changes in taxation and foreign investment policies. <b>Market Risks</b>	
<p><b>You are exposed to market risk.</b></p> <p>Prices of the securities owned by the Fund may rise or fall in response to changes in economic conditions, political conditions, interest rates, and market sentiment. These may cause the price of units of the Fund to go up or down.</p>	
<b>Liquidity Risks</b>	
<p><b>You are exposed to liquidity risk.</b></p> <p>The securities that the Fund owns may at times lack liquidity thereby affecting their value or ease of disposal. The manager may, subject to the trust deed, limit the total number of units which unit holders may dispose if the total number of units to be disposed on any dealing day exceeds 10%.</p>

Notwithstanding the foregoing, the Manager may determine in its discretion that any of the following days shall not be a Dealing Day:-</p> <ol style="list-style-type: none"> <li>(i) any Business Day on which any Recognised Stock Exchange or OTC Market on which substantial portion of the relevant Sub-Fund's Authorised Investments or other property are quoted, listed or dealt in, on an aggregated basis, is not opened for normal trading; or</li> <li>(ii) in respect of Sub-Funds which are Feeder Funds, any Business Day on which the relevant underlying und is not normally traded.</li> </ol>
