# ASIA PACIFIC EX JAPAN EQUITY HIGH DIVIDEND

### Investment objective

The Fund aims to provide capital growth and income by investing in a portfolio of Asia-Pacific (excluding Japan) shares, while promoting environmental, social and governance (ESG) characteristics. The Fund aims to create a portfolio that has a dividend yield above its reference benchmark. The Fund qualifies under Article 8 of SFDR.

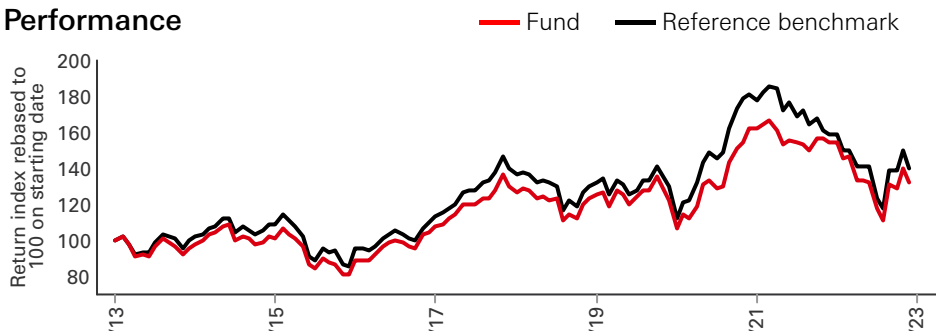
### Investment strategy

The Fund is actively managed. In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size that are based in, Asia-Pacific (excluding Japan) region. The fund invests in both developed markets and emerging markets. The Fund includes the identification and analysis of a company's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. The Fund will not invest in companies with involvement in specific excluded activities, such as: companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction. The Fund can invest up to 50% in China A and China B-shares. The Fund may invest up to 10% in other funds and up to 10% in Real Estate Investment Trusts. ### Main risks

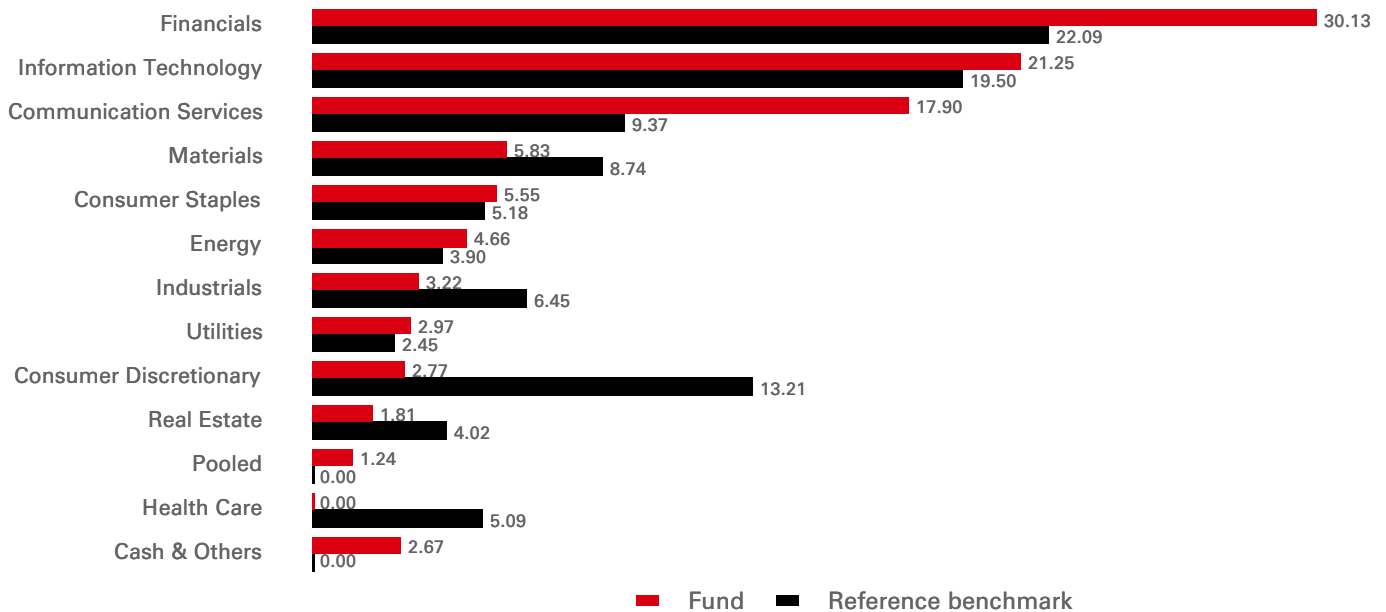

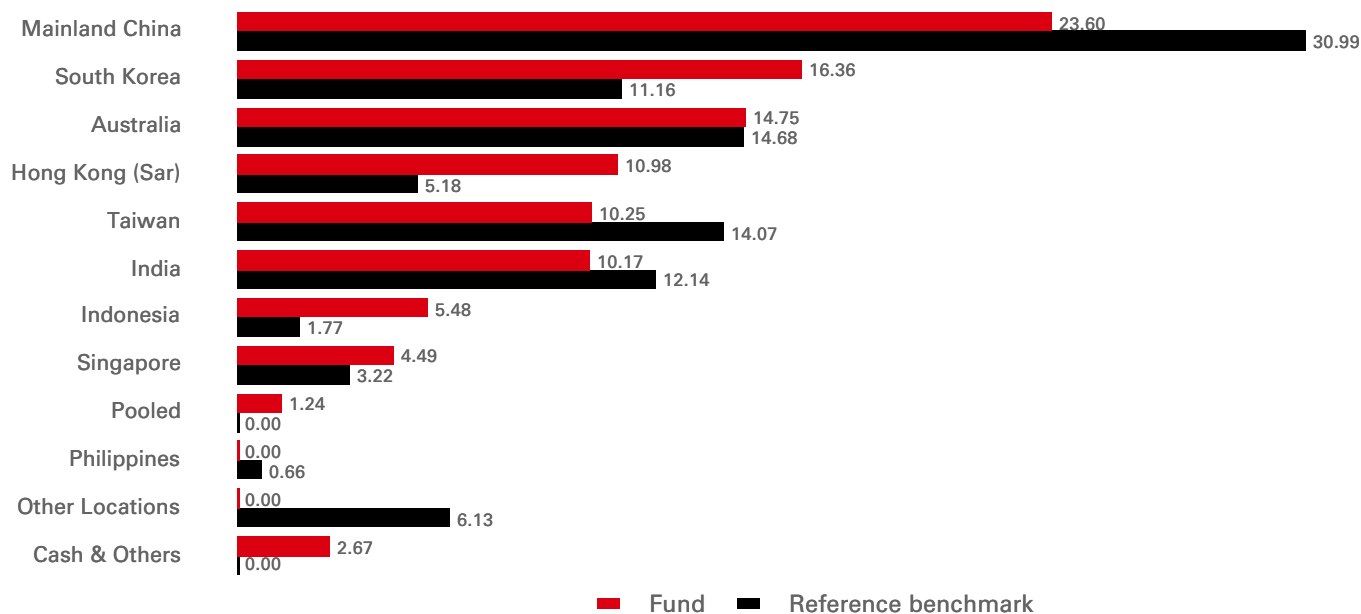

## Monthly performance commentary

Stock selection was negative for the month. Positive performance came from Financials, though this was offset by negative stock selection in Communication Services.

At the country level, stock selection was positive for the month. Positive performance came from Hong Kong (SAR), though this was offset by negative stock selection in Mainland China.

Korea Communication Services security, SK TELECOM with total effect 0.31% was the top contributor. Additionally, Hong Kong (SAR) Financials security, HONG KONG EXCHANGES was the second largest contributor with total effect 0.30%. Mainland China Communication Services security, BAIDU also contributed with total effect 0.26%.

On the other side, detractors included India Communication Services security INDUS TOWERS with total effect -0.50%, Koreaa Financials holding KB FINANCIALS with total effect -0.35%, and Mainland China Communication holding TENCENT with total effect -0.32%.

Sector and country allocation effects are residual to stock selection. At the country level, effects were positive, given an overweight exposure to Korea. At the sector level, effects were positive, given an overweight exposure to Communication Services

Annually distribution is 1; semi-annually distribution is 2; quarterly distribution is 4; monthly distribution is 12. The annualised dividend yield is calculated based on the dividend distribution on the relevant date with dividend reinvested, and may be higher or lower than the actual annual dividend yield.
