The fund aims to provide capital growth in excess of the MSCI China (Net TR) Index after fees have been deducted over a three to five year period by investing in equities of Chinese companies.

The Fund has environmental and/or social characteristics (within the meaning of Article 8 SFDR).

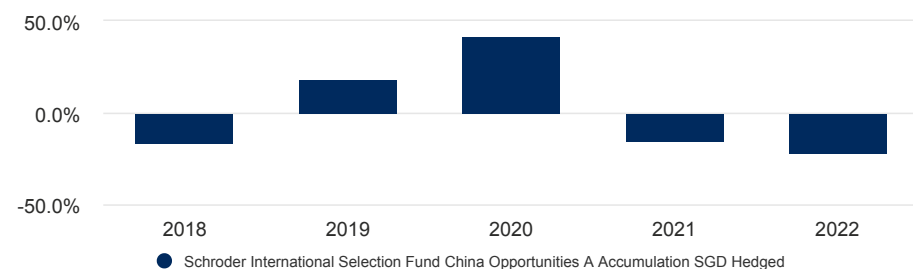

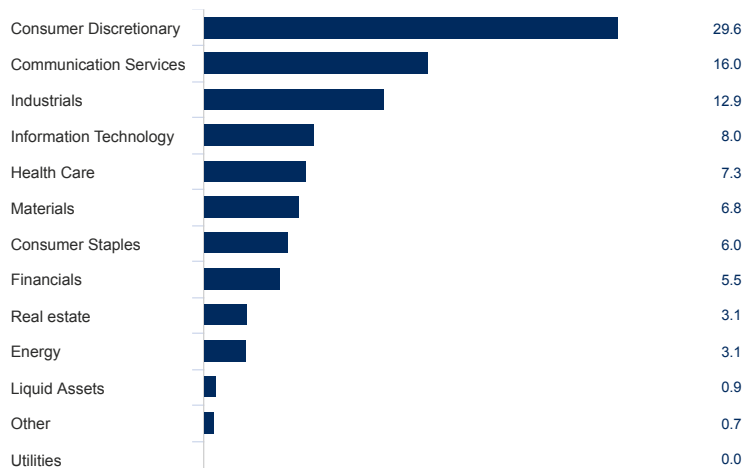

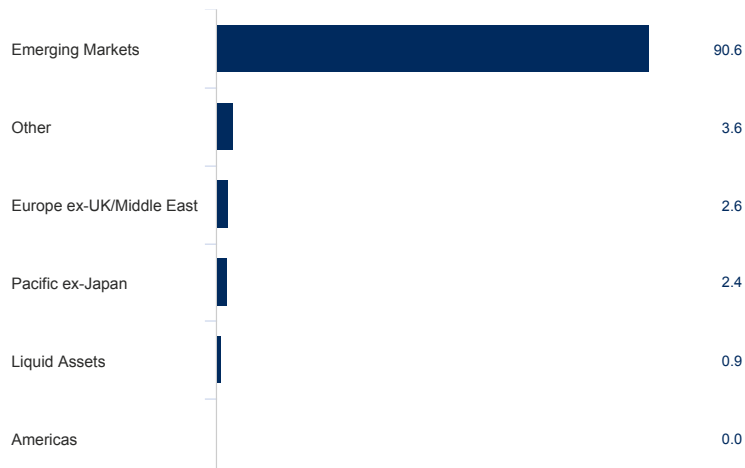
