The Fund has environmental and/or social characteristics (within the meaning of Article 8 SFDR).

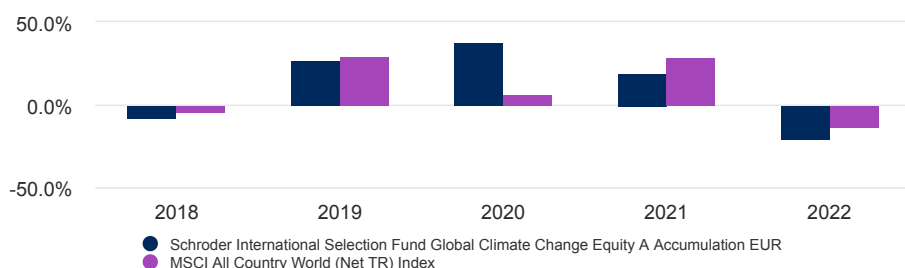

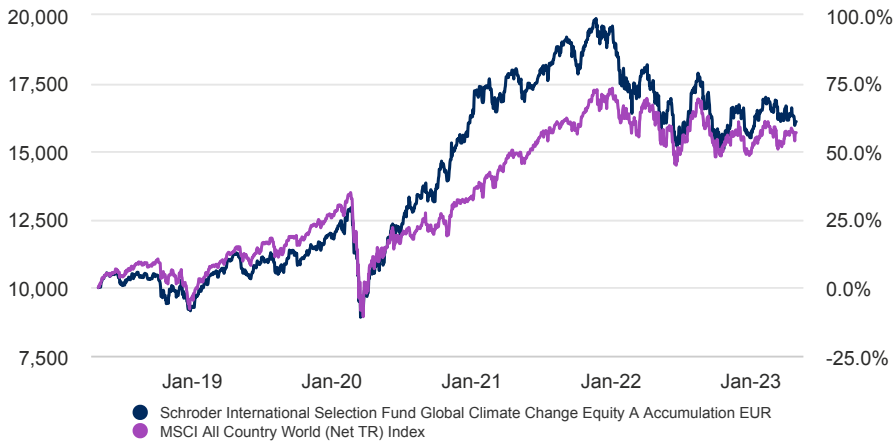

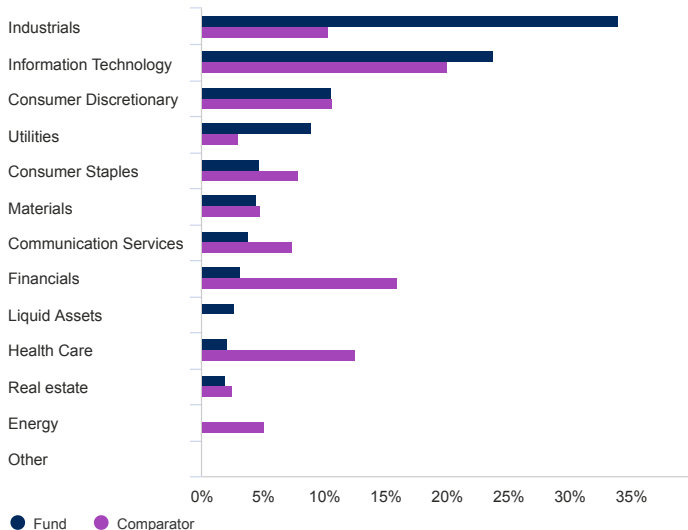

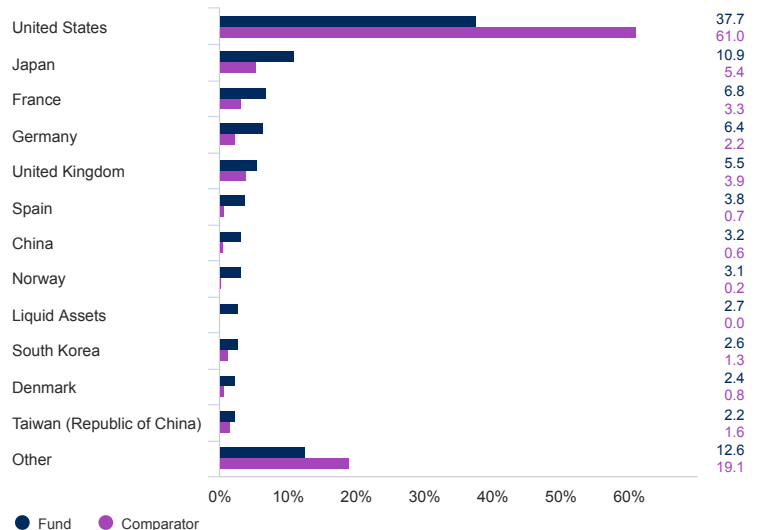

Sector (%)



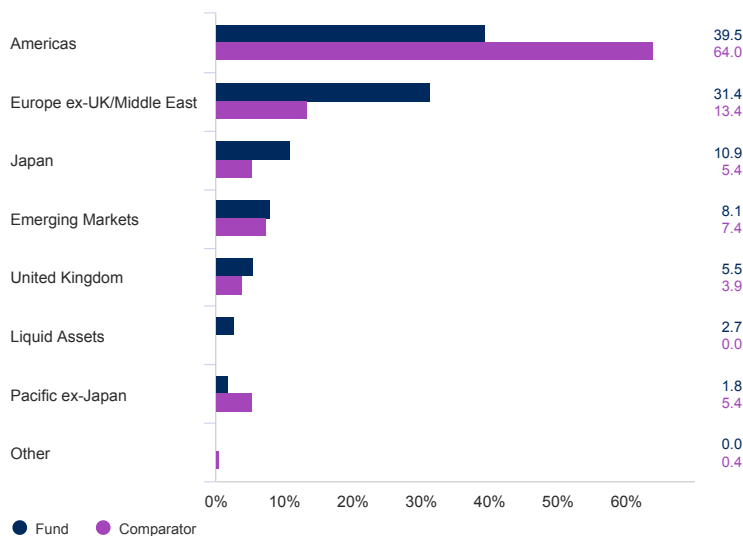
Geographical breakdown (%)
