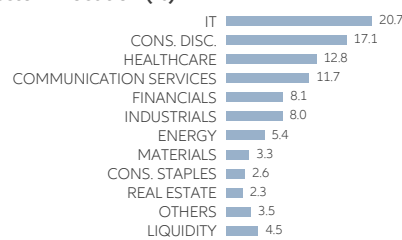

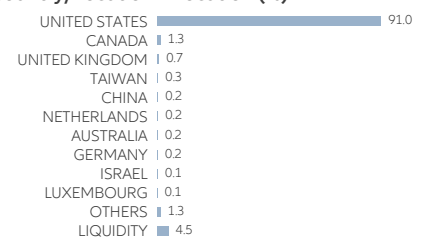
### Asset Allocation (%)
